



### Vendor Agreement for Dog Days at Legacy West event Sept 12, 2020

1. **Right to Set Up a Booth and Distribute Marketing Materials:** Platinum Charities dba Dog Days at Legacy West (DDLW), the event organizer, grants the Vendor permission to set up a booth and distribute marketing materials at the 2020 Dog Days at Legacy West at Legacy West on Saturday, Sept. 12, 2020.
2. **Booth/Table Space:** DDLW will provide space at the event site for the exclusive use of the Vendor. Space is 10'x10'—as is. DDLW is responsible for providing the following contents of their space: 1 table, 2 chairs, and canopy. Vendor is responsible for decorations, signage, display racks, and/or any other accouterments.
3. **Fee:** Vendor agrees to pay the sum of \$160.00 for everything listed in #2 or \$100 for space only.
4. **Electricity:** Electricity will not be provided.
5. **Set Up and Readiness (IMPORTANT):** Vendor agrees to set up their designated space and be ready to perform their activities no later than 9:00am on Saturday, Sept 12, 2020.
6. **Event Hours:** Vendor agrees to have their space open and conducting their designated activities for the full duration of the event from 9:00am to 4:00pm on Saturday, September 12, 2020 at Legacy West.
7. **Break Down and Clean Up:** Vendor agrees to break down their equipment and remove every item they brought with them and all trash, debris, and refuse from their designated space and surrounding area. Vendor is responsible for returning their area to the state it exhibited before their set up.
8. **Responsibilities:** Vendor is responsible for complying with all safety regulations associated with their industry and profession. The vendor also agrees that their staff members coming to the 2020 Dogs Day at Legacy West are certified and/or legally allowed to perform their activities.
9. **Vendor agrees** to indemnify and hold DDLW, its charity partner, sponsors, staff, volunteers, event participants, event spectators, referees, passers-by, Platinum Charities, and DJM Capital harmless from any claims or causes of action arising out of the vendor's participation in, or in any way connected with, the 2020 Dog Days at Legacy West at Legacy West on Saturday, September 12, 2020.
10. **If in the judgment of DDLW** the operation of the Vendor's space or the quality of the services does not meet the requirements of this agreement, or if the vendor is in default of any other terms of

this agreement, DDLW may terminate this agreement in part or in its entirety at any time and even ask the vendor to leave the event site prior to the event ending.

11. **Vendor may terminate this agreement** at any time prior to the event with the understanding that all fees paid to DDLW will be forfeited by the Vendor.
12. **Sales, Distribution, Promoting, or Possession of the following items are prohibited:** illegal substances/activities, hazardous chemicals, animals, guns, other weapons, and toy weapons. DDLW & DJM Capital have the right to determine what is what does not constitute a weapon.
13. **Consent to Recording and Use of Name, Likeness, etc.:** Vendors understands that the event organizers (aka Dog Days at Legacy West, DJM Capital, and Platinum Charities), will be taking photos, videos and audio recordings at the event and if the vendor's image and audio recordings are taken, vendor agrees that the images and audio recordings are wholly owned by the event organizers and can be used for commercial purposes free of charge and interference in the future.
14. **Vendor Liability Insurance:** Please provide a copy of your insurance to us when registering or by 8AM Wednesday, September 9, 2020.
